The lack of security containment fencing. Noise. Wastewater discharge. The reasons for my/our submission are: Concern on property values of neighbouring properties will be negatively affected. Residential care facilities are not a productive use of rural land. We disagree with the statement that the site is not suitable for rural production use as an economic unit (8.2.2). The site is large enough for horticulture purposes such as kiwifruit, or seasonal crops like strawberries or watermelons.

#### **Reasons for submission continued:**

We disagree that the site will generate noise levels which are typical of residential activities and within the noise standards specified for the Rural Zone. Already the noise level experienced from staff on the site has been loud from high music volumes during the day.

We are concerned about residential visitors and residents being able to access our neighboring property as there is a lack of secure fencing and no cameras between the property. We are worried visitors may potentially use our property for illicit access/drug supply as it is concealed from the main road.

At a public meeting we were told there would be up to 40 people visiting the facility plus 8 residents, plus staff. We are concerned the wastewater system will not be up to standard. An upgrade is mentioned, but there are no details and the site has a high water table.
